ARREST - Residential Burglary, Mail Theft, Fraud, Identity Theft, Drug Possession

On January 19th, 2025, officers responded to an apartment complex on the unit block of Mandalay Place on the report of a mail theft. The SSFPD Criminal Investigations Bureau conducted follow-up investigation into the case and identified one of suspects as Zachary Zitzer. Detectives determined that Zitzer was involved in a total of three burglaries at the location for the purpose of mail theft in recent months. On March 20th, 2025 Detectives served a search warrant at Zitzer's residence in connection to the investigation. Zitzer was taken into custody for residential burglary and mail theft as well as numerous other felony fraud, identity theft, and drug possession offenses. Hundreds of pieces of stolen mail and further evidence of a complex fraud operation was located and seized from Zitzer's residence. A second suspect, Joshua Noble, was also contacted at the residence and was taken into custody for felony fraud, identity theft, and drug possession offenses during the search warrant.
