ARREST- Attempted Homicide/Shooting Into An Occupied Dwelling

On April 1, 2026, shortly after 2:00 AM, South San Francisco Police Officers responded to the 300 block of Susie Way for a report of a shooting into building. The suspect, Adan Tafolla had been involved in a dispute with one of the residents in the building the day prior. Tafolla returned to the victim's residence where he burglarized a vehicle. Tafolla then produced a handgun and fired multiple rounds into the building. Two apartments in the building were struck and none of the ten occupants were injured as a result of the shooting. Tafolla fled prior to police arrival. South San Francisco Police detectives were able to determine the location of Tafolla's vehicle and current residence. A search warrant was authored and served in Bay Point, CA. With the assistance of the Contra Costa Sheriff's Office, Tafolla was taken into custody in Brentwood, CA on April 1, 2026. As a result of the search and arrest, evidence was located linking Tafolla to the burglary and shooting. Tafolla was placed under arrest for violations of Attempted Homicide, Shooting into an Occupied Dwelling and Burglary. Tafolla was booked into the San Mateo County Jail. This investigation is still on-going.
