ARREST- Armed Robbery/ Assault with a Deadly Weapon

On April 24, 2026, at around 5:50 P.M., two male suspects robbed two victims at gunpoint in a parking lot on the 300 block of B Street. During the robbery, one of the victims was pistol whipped, which resulted in non-life-threatening injuries. Both suspects fled the scene in a silver sedan. Patrol Officers and Detectives worked diligently to solve the case and ultimately identified the suspects as an 18-year-old male from Daly City and a 17-year-old juvenile male from San Bruno. Detectives subsequently obtained search warrants for both suspects' residences.

On May 6, 2026, South San Francisco Police Detectives in collaboration with North Central Regional SWAT, the San Mateo County Sheriff's Gang Intelligence Unit, and the Daly City Police Department executed the search warrants at both locations. During the warrant service, both suspects were taken into custody for armed robbery, conspiracy and assault with a deadly weapon and evidence of the crime was recovered. The adult suspect was later booked into San Mateo County Jail, and the juvenile is pending booking at the Hillcrest Juvenile Detention Facility.
