ARREST- Residential Burglary, Fraud, Narcotics Possession

On 07/14/26 at approximately 5:15 P.M., South San Francisco Police officers responded to a residence on the 300 block of Arroyo Drive on the report of a burglary. Upon arrival, officers located two suspects, later identified as Arvin Ibasan (41, San Francisco) and Christopher Roliz-Maguigad (37, Seaside), inside. The investigation revealed the suspects forced entry into the residence, which was vacant at the time, changed the locks, and began operating a counterfeit currency manufacturing operation. Evidence of identity theft, as well as various controlled substances were also located. Ibasan and Roliz-Maguigad were placed under arrest for burglary, fraud, counterfeiting, and narcotics related charges and were later booked into the San Mateo County Jail without incident. This case remains under investigation and anyone with information pertaining to the case is encouraged to call 650-877-8900 and ask to speak with the burglary detective.
